Any form of physical, mental, emotional, or sexual abuse is punishable by law and Upward Bound is bound by law to report allegations of abuse to proper authorities. All camp staff are mandatory reporters. All reporting is kept confidential and will in no way harm a team member's position with this organization.

The camp may terminate employment or volunteer service of any person found to have a history of complaints of abuse and/or found to have resigned, been terminated or been asked to resign from a position whether paid or unpaid, due to complaint(s) of any form of abuse.
